3. Additional Incentives for Purchase of Electric Vehicles (EVs).

- (a) Beneficiaries will be entitled to purchase EVs costing upto ₹ 5 Lakh more than the limits stipulated at Para 2 above.
- (b) Beneficiaries purchasing an EV for the first time can purchase the **EV after six years of previous four wheeler purchase**. However, the next purchase (EV/ Diesel/ Petrol/ CNG/ Hybrid) is permitted after a gap of eight years only.
